

The OurStage “Free Ticket Friday” Concert Ticket Giveaway Sweepstakes Official Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

PRIZE WINNERS: OPEN ONLY TO ENTRANTS WHO ARE LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES OR THE DISTRICT OF COLUMBIA AND ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED BY LAW. THESE OFFICIAL RULES OUTLINE THE OURSTAGE “#FREETICKETFRIDAY” SWEEPSTAKES (“SWEEPSTAKES”).

SWEEPSTAKES DESCRIPTION:

ELIGIBILITY: Entrants must have Internet access, must have a Twitter account (<https://twitter.com/>), must be eighteen (18) years of age or older at the time of entry, and must be legal residents of the 48 contiguous United States or the District of Columbia. The following are not eligible: employees, contractors, directors and officers of OurStage INC., and the immediate family members of OurStage employees (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes).

TO ENTER: TO ENTER: No purchase necessary. OurStage, Inc., (“OurStage”, “OurStage.com”, “www.OurStage.com”) wants to reward Entrants for promoting the OurStage brand on <https://twitter.com/>. By retweeting the phrase “#FreeTicketFriday” the Entrant will be entered into the “Free Ticket Friday” Concert Ticket Giveaway Sweepstakes for a chance to win two (2) free concert tickets* to any concert in the contiguous United States or the District of Columbia.

*ADDITIONAL RULES APPLY. See “Sweepstakes Grand Prize” section below.

SWEEPSTAKES PERIOD: The OurStage “Free Ticket Friday” Ticket Giveaway Sweepstakes begins on October 19th, 2012 at 1:00:00 pm ET and ends on October 22nd, 2012 at 1:00:00 pm ET (“Sweepstakes Period”).

PRIZE WINNERS: For purposes of these Official Rules, the winners of the Sweepstakes shall be referred to as the “Prize Winners”.

SWEEPSTAKES GRAND PRIZE:

One (1) Sweepstakes Grand Prize Winner will receive:

- Two (2) tickets for admission to attend one (1) live music event of the winner’s choosing, provided said event is scheduled within one (1) calendar year from October 22nd, 2012, that said concert is within the 48 contiguous United States or the District of Columbia, and that the combined ticket cost DOES NOT exceed \$200 USD. Travel and accommodations are NOT provided. Two (2) week grace period must be allowed for OurStage to ensure ticket purchase. OurStage will make best efforts to obtain the tickets requested by the Grand Prize Winner as long as tickets are publicly available at the time of the winner’s request.

Estimated retail value (ERV): \$200 USD.

SELECTION AND NOTIFICATION OF PRIZE WINNERS: One (1) Sweepstakes Entrant will be chosen at random from a pool of collected twitter handles (@Example) to be deemed the Grand Prize Winner. Entrants must be eighteen (18) years of age or older at time of entry and legal residents of the 48 contiguous United States or the District of Columbia to be eligible. Odds of winning depend on the number of entries received. Potential winners will be notified via **Twitter Direct Message and prompted for email address. Once email address is received, potential winner will be prompted to carefully review the rules and provide to OurStage the information for the concert they would like to attend.** Potential winners will be required to complete an Affidavit of Eligibility and Release ("**Release**") which must be returned within five (5) days of the date such notice is sent or such other date selected by Administrator. If such notification or any Sweepstakes Prize is returned as undeliverable, or if potential winner does not respond within 48 hours from the date of notification, or if potential winner does not return the Release as directed, the Sweepstakes Prize will be forfeited and Administrator will choose an alternate potential winner from among the remaining eligible entries received during that Sweepstakes Period. Prize Winners are solely responsible for reporting and paying any applicable taxes on their Sweepstakes Prize. By accepting a Sweepstakes Prize, winners agree that the Sponsors and Sweepstakes Parties have the right to use winner's name and image, entry, and biographical information for advertising/promotional purposes, except where prohibited by law, without notice or compensation.
