

2013 OurStage Intel® “Superstars” Competition Fan Sweepstakes Official Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. OPEN ONLY TO OURSTAGE ACCOUNT-HOLDERS WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA AND ARE THIRTEEN (13) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED BY LAW. THESE OFFICIAL RULES OUTLINE THE INTEL “SUPERSTARS” COMPETITION SWEEPSTAKES (“SWEEPSTAKES”).

- 1. SWEEPSTAKES DESCRIPTION:** OurStage, Inc., (“OurStage”, “OurStage.com”, “www.OurStage.com” or “Administrator”) wants to reward its community for recognizing and discovering new talent. Sweepstakes participants will be able to judge on the entries submitted by contestants on www.OurStage.com. By judging in the Intel “Superstars” Competition (“Contest”), participants will be entered into the Sweepstakes for a chance to win the Sweepstakes Prize (“Prize”). Participants may judge as often as they like, but each participant is limited to four (4) Sweepstakes entries per registered member, per day. Either “Sort4” and/or “Head-to-Head” battles are acceptable forms of judging on www.OurStage.com (“Website”).
- 2. ELIGIBILITY:** Open to OurStage account holders who have Internet access and are thirteen (13) years of age or older at the time of entry, and who are legal residents of the 50 United States or the District of Columbia. The following are not eligible: employees, contractors, directors and officers of Sponsors, and each of their respective parent, subsidiaries and affiliated companies, distributors, web design, advertising, fulfillment, judging and Sweepstakes agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, “Sweepstakes Parties”), and the immediate family members of each (spouse, parent, child, sibling, grandparent, and spouse or “step” of each) and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes).
- 3. SWEEPSTAKES PERIOD:** The Sweepstakes begins noon Eastern Time (“ET”) on August 15, 2013 and ends at 11:59:59 am ET on December 20, 2013 (“Sweepstakes Period”).
- 4. TO ENTER:** Any OurStage account holder who judges one or more battles in the Intel “Superstars” Competition will automatically be entered for a chance to win the Prize. One battle completed per “Superstars” channel (eight total channels, four channels per Round) results in one entry, with a maximum potential of four entries per day, per account holder. Account holders are encouraged to judge as many times as they like.
- 5. PRIZING:** For purposes of these Official Rules, the winners of the Sweepstakes shall be referred to as the “Prize Winners.”
 - a.** Three (3) Prize Winners will be selected in total. One (1) Prize Winner will be selected at random (see Section 6, below) from each Round of judging (Round 1 runs from noon on August 15, 2013 to October 7, 2013; Round 2 runs from noon on October 7, 2013 to November 30, 2013; Round 3 runs from noon on November 30, 2013 to December 15, 2013). Each of the three (3) Prize Winners

will receive:

- 6. SELECTION AND NOTIFICATION OF PRIZE WINNERS:** Each battle judged will count as one (1) sweepstakes entry per eligible entrant, with a maximum of four entries per day. At the end of the Competition Fan Sweepstakes Entry Period, one (1) winner will be selected in a random drawing from among all eligible entries received during the Fan Sweepstakes Entry Period. Odds of winning depend on the number of entries received and the number of battles completed per eligible entrant. Potential winners will be notified via email at the address provided during registration. Potential winners (or their parent/legal guardian if potential winner is an eligible minor) will be required to complete an Affidavit of Eligibility and Release (“Release”) which must be returned within five (5) days of the date such notice is sent or such other date selected by Administrator. If such notification or any Sweepstakes Prize is returned as undeliverable, or if potential winner does not respond within 48 hours from the date of notification, or if potential winner does not return the Release as directed, the Sweepstakes Prize will be forfeited and Administrator will choose an alternate potential winner from among the remaining eligible entries received during that Sweepstakes Period. Prize Winners are solely responsible for reporting and paying any applicable taxes on their Sweepstakes Prize. By accepting a Sweepstakes Prize, winners (or their parent/legal guardian if an eligible minor) agree that the Sponsors and Sweepstakes Parties have the right to use winner's name, entry, and biographical information for advertising/promotional purposes, except where prohibited by law, without notice or compensation.

Entrants agree that the Sponsors have the sole right to decide all matters and disputes arising from this Sweepstakes and that all decisions of Sponsors are final and binding. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsors reserve the right, at their sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, modify, or terminate the Sweepstakes or any part of the Sweepstakes. This Sweepstakes is governed by the laws of the Commonwealth of Massachusetts, with venue in Middlesex County, Massachusetts, and all claims must be resolved in the federal or state courts located in Middlesex County, Massachusetts.
